### **Code of Federal Regulations (CFR)**

- The Code of Federal Regulations is an electronic National Archives of policies.
- It was created under Title IV of the Energy Conservation Reduction Act.
  - DOE uses this law, in collaboration with the Federal Register, to create requirements for the Wx program. It is divided into 50 sections. 10 CFR 440 is the portion directly related to the Wx program.
- This includes policies for all federal entities such as the Department of Energy (DOE).
- The 10 CFR must be approved by Congress in order to be updated.
- These policies can be found <u>here</u>.

### **DOE WPNs**

- DOE releases WPNs to the Weatherization Grantee's (ex. ODOC).
- These are interpretations of the CFR by DOE. The CFR provides the law while the WPN provides the Grantee more guidance on implementation and regulations. This can oftentimes be a direction to the Grantee to write policies that fall within the bounds of DOE's WPN.
- These WPNs are released to provide guidance to the Wx network that include an annual ACPU limit, measures that are allowed, new technology programs, etc.

### **OK Weatherization Operations Manual**

- The Operations Manual is where the bulk of programmatic, fiscal, and client file requirements are found. This includes procurement, inventory, client file numbering, etc. The Operations Manual can be found on our website <a href="here">here</a>.
- Most of the policies in the Operations Manual have been transferred from the CAA Implementation Manual (CSBG Manual).
   This means that most of these policies are not new overall, just found in a new document.
  - The new Operations Manual was released at the Fall 2022 OKACAA Conference.
- On November 1<sup>st</sup> of each year, ODOC will take the last year's worth of WPNs and include them into the OK Weatherization Operations Manual.
  - Ideally, ODOC will release an updated, consolidated Operations Manual annually for the next contract year.

### **OK Field Guide**

- The field guide that service providers are required to use. Previously, there had been one for Single Family Units and one for Mobile Homes. The most recent DOE-approved Field Guide has combined all SWS standards for both Single Family and Mobile Homes into a single manual. This guide aligns Standard Work Specifications with DOE allowable measures and ODOC policies. The most current field guide can always be found on our ODOC website here.
- ODOC will periodically update the Field Guide as needed, but it is not necessarily scheduled like the Operations Manual.

### **Energy Audit Manual**

- ODOC may update the Energy Audit Manual periodically, as needed, but at minimum, it is reviewed and updated every five
  years along with the Energy Audit Renewal process through DOE.
