SUMMARY:

This action is to reflect statutory amendments made transferring the Tourism Development Act Tax Credit Program from the Oklahoma Tourism and Recreation Department to the Oklahoma Department of Commerce. This corrects definitions and information about the application that had been rendered incorrect based on the statutory amendments.
